  - (Selected trips ran to both Oatley West & Oatley Point.)
  - \* *These trips may have been numbered 950 and/or 953 for a period.*
- Operated by Moore's Tours (Trevor Moore).
- Selected weeknight & all Sunday trips on AJ Moore's combined 74/106 [1925 route numbers] and Moore's Tours 954 combined as Hurstville – Connells Point – Hurstville Grove – Oatley (weeknights) & Hurstville – Hurstville Grove – Oatley (Sundays). These trips may have been numbered as 950 for a period. They were described in timetables as being "amalgamated routes operated by Moore's Tours, AJ Moore & Premier Coaches." As only one bus was required to operate these weeknight & Sunday services, it is understood they were provided on a roster basis between the operators concerned.

##### **5 December 1999:**

- Remaining trips (morning peak and early afternoon peak) on combined 117/118 [1925 route numbers] (Oatley – Oatley Point & Oatley – Gungah Bay) transferred from Premier Coaches to Moore's Tours (Trevor Moore) & renumbered part of 954.
- Selected peak hour trips on 954 further extended to run:
  - Hurstville – Hurstville Grove – Oatley – Oatley Point (Algernon St/Clifton St).
  - Hurstville – Hurstville Grove – Oatley – Oatley West (Lansdowne Pde/Baker St).
- Selected peak hour trips ran Mortdale – Oatley – Oatley Point – Gungah Bay – West Oatley, probably mainly to convey school children (still operative as at 20 May 2001).
- "Amalgamated" trips then operated by Moore's Tours & AJ Moore.

##### **22 December 2004:**

- Transferred to Punchbowl Bus Co (Griffin family/Steve Scott) after Moore's Tours gave notice to discontinue contract with Ministry of Transport.
- Routes beyond Oatley Station to Oatley West and Oatley Point (Rosa & Herbert Sts) standardised.
- Trips to Mortdale ceased by this date (or became school trips?).
- Weeknight trips ran as combined 953/954.

##### **1 January 2005:** Became part of Contract Region 5.

##### **22 March 2010:** As a result of Ministry of Transport review of Contract Region 5, rearranged as:

- 954 Hurstville – Hurstville Grove.
- 955 Hurstville – Oatley – Oatley Point – Oatley West – Mortdale.

### **HURSTVILLE – CARSS PARK – KOGARAH – ROCKDALE PLAZA**

### **HURSTVILLE – HURSTVILLE (George & West Sts)**

#### **Timeline**

**By 2 March 1992:** Hurstville – Carss Park & Hurstville – Hurstville (George & West Sts) renumbered from 109 [1925 route number]. Operated by Carss Park Charter Tours (O’Nains family).

**29 December 1993:** Transferred to Southtrans (Deane family).

**26 September 1994:** Hurstville – Carss Park & Hurstville – Hurstville (George & West Sts) amalgamated with 121 [1925 route number] to become 958, Hurstville – Carss Park – Kogarah. Separate trips to George & West Sts ceased.

**20 October 1997:** Extended from Kogarah to Rockdale Plaza. Extension soon after suspended due to a “territory” dispute with State Transit Authority, but dispute later resolved and extension reinstated.

**27 September 1999:** Southtrans transferred to CGEA Transport.

**July 2000:** Operator’s name changed to Connex Southtrans.

**By June 2002:** Operator’s name changed to Connex NSW.

**1 January 2005:** Became part of Contract Region 10.

**18 April 2006:** Operator’s name changed to Veolia Transport

**1 July 2013:** Operator’s name changed to Transdev following the merger of Transdev & Veolia Transport on 3 March 2011.
