MILPERRA BRIDGE – REVESBY – REVESBY HEIGHTS■

Timeline

27 February 1984:

- Milperra Bridge – Revesby – Revesby Heights commenced, replacing parts of 22, 38 & 137 [1925 route numbers], as part of reorganisation of South Western's South Bankstown routes.
- Service to Revesby Heights also provided by 926 from Bankstown via Padstow.
- Operated by South Western Coach Lines (Max Holman).

6 March 1985: Transferred to Highway Tours (JD (Jim) Hill).

13 May 1987: Altered to run Milperra – Revesby – Revesby Heights (weekday peak hours) & Milperra – Padstow – Roselands (off-peak & Saturdays), the latter replacing part of 928. Milperra – Milperra Bridge ceased apart from school trips.

November 1988: Transferred to Danastra Pty Ltd, trading as Revesby Bus & Coach Service (Colin Crossley, proprietor).

April 1996: Operator's name altered to Crossley Bus Lines.

10 January 1990: Altered to run Milperra – Revesby – Bankstown, but with selected trips running Milperra – Revesby – Roselands (*not* via Padstow). 926 continued to serve Revesby Heights.

26 November 2001: Transferred to Connex NSW.

1 January 2005: Became part of Contract Region 10.

18 April 2006: Operator's name changed to Veolia Transport

18 September 2006: As a result of Ministry of Transport review of Contract Region 13 (including 922-927 in Contract Region 10):

- Ceased. Revesby – Milperra replaced by S5.
- Existing 923, 924 & 926 continued to run between Bankstown & Revesby.

From Bankstown (bus terminal off South Tce) via West Tce, Raymond St, Restwell St, Macauley Av, Chapel Rd, then reverse route to Bullecourt Av/Ashford Av (Milperra).

Milperra – Revesby – Roselands

Same as Milperra – Revesby – Bankstown (*above*) between Milperra and Revesby. Remainder of route not specified in timetable.

Alteration

By 4 October 1993: Ex Milperra from Killara Av via Horsley Rd, Panania Av, Topping St, Braesmere Rd (**Panania**), Anderson Av, Horsley Rd. Reverse on return.

LIDCOMBE – BANKSTOWN – CONDELL PARK – PANANIA – EAST HILLS

Timeline

18 September 2006:

- New route, Bankstown – Condell Park – Panania – East Hills, replacing parts of 924, 925, 926, 930 & 935 as a result of Ministry of Transport review of Contract Region 13.
- Selected trips ran Bankstown – Bankstown Hospital.
- Operated by Transit First (Thelkeld family).

1 February 2007: Transferred to Veolia Transport.

14 December 2009: 912 & 925 amalgamated as 925, Lidcombe – Bankstown – Condell Park – Panania – East Hills. Selected trips continue to run Bankstown – Bankstown Hospital or Lidcombe – Bankstown – Bankstown Hospital.

14 March 2011: Rerouted via Muir Rd & Hume Hwy instead of part of Rookwood Rd. Rerouted 908 serves part of missed section of Rookwood Rd.

1 July 2013: Operator's name changed to Transdev following the merger of Transdev & Veolia Transport on 3 March 2011.

6 August 2023:

- Contract Regions 3 & 13 consolidated as Contract Region 3.
- Transferred to Transit Systems NSW Pty Ltd, trading as Transit Systems, as successful tenderer for bus services in consolidated Contract Region 3.

- **Extended from Revesby Heights to Padstow (weekday off-peak, from 2008)**

(Bankstown Square [shopping centre] was rebranded Bankstown Centro in 2003, then Bankstown Central in 2013.)

Timeline

27 February 1984:

- Bankstown – Bankstown Hospital – Padstow – Revesby Heights renumbered from parts of 38 [1925 route number], as part of reorganisation of South Western's South Bankstown routes.
- Service to Revesby Heights also provided by 925 from Milperra via Revesby until 10 January 1990.
- Operated by South Western Coach Lines (Max Holman).

6 March 1985: Transferred to Highway Tours (JD (Jim) Hill).

13 May 1987:

- Rerouted via Queen St, Revesby (partly replacing diversions of 923 via Sherwood St) instead of Mackenzie & Doyle Rds (replaced by 924 & 925).
- Sunday service to Revesby Heights provided by diversion of 923.

November 1988: Transferred to Revesby Bus & Coach Service (Colin Crossley, proprietor).

April 1996: Transferred to Danastra Pty Ltd, trading as Crossley Bus Lines (Colin Crossley & EM (Eddie) Hayman, proprietors).

26 November 2001: Transferred to Connex NSW.

1 January 2005: Became part of Contract Region 10.

18 April 2006: Operator's name changed to Veolia Transport

18 September 2006: Altered to run Bankstown – Revesby – Revesby Heights as a result of Ministry of Transport review of Contract Region 13 (including 922-927 in Contract Region 10).

8 December 2008: Extended from Revesby Heights to Padstow in weekday off-peak to replace equivalent part of S5.

1 July 2013: Operator's name changed to Transdev following the merger of Transdev & Veolia Transport on 3 March 2011.

1 July 2023: Transferred to U-Go Mobility Pty Ltd (a 50-50 joint venture of UGL & Go-Ahead Group), as successful tenderer for bus services in Contract Region 10, coincident with consolidation of Contract Regions 5 & 10 as Contract Region 10.

22 June 2026: As part of a review of Contract Region 10 services following consolidation of Contract Regions 5 & 10 in 2023:

- Curtailed to run Bankstown – Revesby Heights at all times.
- Off-peak trips between Padstow & Revesby Heights replaced by extended 927.

BANKSTOWN – PADSTOW – ONE TREE POINT

- Extended from Padstow to Revesby Heights (off-peak from 2026)**

(One Tree Point is a locality in the suburb of Padstow Heights.)

27 February 1984: Renumbered from 24 [1925 route number]. Operated by South Western Coach Lines (Max Holman).

6 March 1985: Transferred to Highway Tours (JD (Jim) Hill).

16 December 1985: Rerouted via Marshall St & Hoskins Av, Bankstown, instead of Chapel Rd, replacing part of 176 [1925 route number], which ceased.

13 May 1987: Rerouted back to Chapel Rd, Bankstown. Service in Marshall St & Hoskins Av replaced by 924.

November 1988: Transferred to Revesby Bus & Coach Service (Colin Crossley, proprietor).

April 1996: Transferred to Danastra Pty Ltd, trading as Crossley Bus Lines (Colin Crossley & EM (Eddie) Hayman, proprietors).
